Student Orientation Requirements

Student Immunizations and Exposure Requirements Student must submit medical documentation of immunization records to their school/educational program. Discuss any medical and/or religious exemption requests with site contact.	
MMR (measles/mumps/rubella)	2 shots <u>or</u> titer (blood test)
Varicella (chicken pox)	Complete ONE of the following: • 2 shots <u>or</u> titer (blood test) • <u>Health care provider</u> documentation of varicella (chicken pox) <u>or</u> herpes zoster (Shingles); either are acceptable to verify immunity.
	A statement of history of the disease will not be accepted, even if written on the vaccination report.
Tuberculosis (TB)	Complete ONE of the following for initial TB test: • 2-step TB skin test (TST) • T-SPOT.TB • QuantiFERON (QFT) Must complete TB symptom screen. Discuss any student(s) with history of a positive TB test and student(s) who are experiencing TB signs and symptoms, with Sanford Health contact.
Influenza and COVID 19 vaccine	Influenza: 1 dose annually ; COVID 19: as directed by Sanford Health/GSS
Hepatitis B series	3 doses of vaccine <u>or</u> titer (blood test); recommended, not required
Td/Tdap	Documentation of up-to-date Td/Tdap vaccination; recommended, not required

Student Criminal Background Study Requirements

A national background study must be completed for each student that includes:

- 1) Criminal charges
- 2) Sex offender status
- 3) Social security trace
- 4) OIG & GSA check

The Educational Program must inform Affiliate Designee/Site Contact of any student infractions revealed on the background check.

NOTE: For MN and IA locations, a State Department of Health background study may also be required.

All student immunization/exposure and background documents are retained by the school and must be available upon request.
