Students have one opportunity to request a deferral of resequencing to our nursing programs. A Deferral of Resequencing application is needed for the following circumstances:

- 1. The student has completed at least one semester of nursing courses with a passing grade in all nursing courses.
- 2. The student has applied for resequencing to the nursing program in semesters 2, 3 or 4, and has been approved by the Student Affairs Committee to return to the nursing program.
- 3. The student can demonstrate that deferring their seat for a maximum of one year past the point of application is necessary for personal, financial, or academic reasons.

Nursing Handbook Policy: (Updated 11/21):

A student who has been granted resequencing may request deferral of their seat and a return to the program more than one year (but no more than two academic years) following the date of resequencing approval. Students selecting this option will not be required to reapply to the program. Instead, they will follow a resequencing-deferral process, and will be required to retake all courses in all semesters. Students who select this option will have used both their resequencing application and the deferral application. Therefore, if the student fails any subsequent courses or earns a grade below a C, the student will be required to reapply to the program. A student who uses this option and is granted readmission to the program is not eligible for resequencing or deferral process on the second admission cycle. Students who select this option must first complete the resequencing-deferral process form and create an academic plan with their advisor.

For deferral of resequencing to be considered, all required documentation must be submitted to the nursing office by the add-drop date of the semester in which the resequencing was scheduled to begin. Failure to submit all documentation will forfeit opportunity for deferral. Students will be notified by the Student Affairs Committee of resequencing acceptance or denial. Generally, students are notified within two weeks of the resequencing deadline.

- 6. The student has no more than one year to return to the nursing program after a deferral request.
