## **NTC FAO SUMMER CERTIFICATION**

**NOTE:** Summer is considered one semester for financial aid, registration, and billing purposes. If you are attending multiple sessions or have courses with a start date that is **NOT** May 15, **you will need to register for all of your summer classes at the start of the summer term to be eligible for grants.** You must enroll at least half-time (6 credits) to be eligible for a Federal student loan.

**CAUTION:** Only approved courses REQUIRED to graduate from your declared NTC program major can be counted for the purpose of calculating financial aid eligibility. **Contact the Financial Aid Office immediately if your enrollment changes.** A change in enrollment could affect your financial aid eligibility.

## FOR SUMMER 2023 FINANCIAL AID, I UNDERSTAND:

- New entering students for Summer 2023: I must be admitted as a *regular* student pursuing a degree or diploma offered at NTC and complete the entire 2022-2023 application process, including, but not limited to, the 2022-2023 FAFSA and other institutional forms required.
- I must maintain enrollment for the number of credits upon which my financial aid was based. If I fail to attend a summer enrollment period after indicating I would do so, I agree to notify the Financial Aid Office immediately and understand I may be required to return funds.
- Summer 2023 aid is subject to the outcome of the satisfactory academic progress review, which is conducted after Spring 2023 grades are posted.
- ➤ I may charge my books to my NTC student account at the NTC on-campus bookstore from April 17 May 19, 2023, if I am registered for at least one NTC course in the summer term.
- I must complete the registration process for ALL summer classes by May 19, 2023. Summer aid will first be applied to all summer charges prior to any balance being disbursed.
- A change in my enrollment caused by dropping classes prior to the start date of a class, withdrawal from all classes, cancelled classes, or any other enrollment change, may require the repayment of financial aid.
- ➤ If I have borrowed my maximum annual Federal Direct Loan limit for the 2022-2023 school year during fall and spring, I will not have remaining eligibility for summer.
- Financial Aid will be disbursed **May 26, 2023**. I may need to utilize my own resources for initial costs, including supplies, rent, etc.
- Loan entrance counseling at NTC is required of all first time Direct Loan borrowers prior to the first disbursement. For loan entrance counseling, follow the directions at this web site: <a href="https://studentaid.gov">https://studentaid.gov</a> (click In School tab and look under Popular Topics), and select Northwest Technical College as your institution of choice. This will send the results electronically to the NTC Financial Aid Office. First time Direct Loan borrowers must also complete an electronic Master Promissory Note at: <a href="https://studentaid.gov">https://studentaid.gov</a> (click Complete MPN under Popular Topics). To complete the electronic Master Promissory Note, you will need your Federal FSA ID, your driver's license number, and names, addresses, and phone numbers of two personal references from two different households. Please be sure to read the instructions and information carefully.
- Any financial aid overage money will either be disbursed by direct deposit or a check will be mailed to my permanent address on file. Students can sign up for direct deposit on e-Services (click on MyNTC, log-in, e-Services, financial aid, direct deposit).
- > My financial aid at NTC will only automatically be applied to my bill at NTC. I am responsible to pay all other school bills out-of-pocket or with any disbursed financial aid.
- My financial aid offer may be accessed through my e-Services account once your processing is complete. To view your financial aid offer, simply go to <a href="https://www.ntcmn.edu">www.ntcmn.edu</a>, MyNTC, log in, and click e-Services, click financial aid on the left, and then select award letter. You may have to adjust the semester.
